AIRCRAFT". RO AT THAT TIME TRIED TO ESCORT THE SUBJECT OUT OF HIS SEAT. THE
SUBJECT BECAME COMBATIVE TOWARDS RO LONG, SWING HIS HANDS. RO LONG
